- At the time of application, the candidate must have been a BOSLA life member for three years in a row.
- While serving on a BOSLA committee, a member is not eligible to apply for the same.
- The applicant should be under 45 years old (as on 31st July 2025)

Criteria:

- The award recognizes applicants' contribution towards the profession and Association
- Specific achievements or sustained excellence in fulfilling to acquire, organize, interpret, and provide access to information and knowledge
- Significant impact on the library profession and services
- A consistent embodiment of the highest standards of librarianship, which enhance the activities and quality
- Research Papers published in National and international journals
- Contributions in books, chapters in books and conference proceedings
- Participation in National / International conferences for presenting papers
- Personal and professional Achievements
- Significant contribution in their libraries and active participation in BOSLA events

Number of Awards

- Only one Award will be honored annually
- A member and professional will receive the award only once

Submission Date: Online Application submit on or before August 05, 2025. The application received after this date will not be considered.

Selection Committee: The selection committee will be appointed by the Chairman of BOSLA. It will comprise of three/Five members. The selection committee will scrutinize the applications, select, and make a recommendation to the Chairman, who will take the final decision

Award Ceremony: The selected distinguished Librarian / LIS professional will be honored in the upcoming BOSLA event. No Travel Allowance (TA) or Daily Allowance (DA) shall be provided to the awardees for attending the award function or any related BOSLA event.
